The open portions of this meeting will be streamed live and recorded. The video will be made available to the public on the District's website.

PUBLIC COMMENT – Public comments related to this meeting will be accepted in person only in accordance with the Open Meetings Act and Local District Policy, BED(LOCAL). Members of the public wishing to address the Board during the public comment portion of this Special meeting shall be limited to the items on the agenda and five minutes, or less, should a change to the allotted time be necessary as determined by the presiding officer based on the meeting.

In-person participants must either sign up online by 7:00 am the day of the meeting or sign in and complete a "Public Comment Participation Form" and present it to the Board President or designee 10 minutes prior to the start of the meeting. If a completed form for public comment is not received by the applicable deadline posted, the individual will not be able to participate in public comment at this meeting.

In accordance with the Texas Open Meetings Act, Board Members will listen to the comments. The Board, through the presiding officer or Superintendent, can offer factual information, cite Board policy, or direct the administration to investigate items and report back to the Board, but shall not engage in a two-way dialogue with patrons.

AN ORDER CANVASSING RETURNS AND DECLARING THE RESULTS
OF A BOND ELECTION HELD IN THE MIDLOTHIAN INDEPENDENT
SCHOOL DISTRICT ON MAY 6, 2023

WHEREAS, the Board of Trustees (the “Board”) of Midlothian Independent School District (the “District”) duly authorized a bond election (the “Election”) to be held within the District on May 6, 2023, for the purpose of submitting to the resident qualified electors of the District the propositions hereinafter set forth; and

WHEREAS, the Board has investigated all matters pertaining to the Election, including the ordering, giving notice, appointing officers, and holding and making returns of the Election; and

WHEREAS, the election officers who conducted the Election have duly made the returns of the results thereof; and said returns have been duly delivered to the Board for official canvassing of the returns thereof; and

WHEREAS, upon the consideration of the returns of the Election, it appears that the same was held in accordance with the authorizing proceedings and was in all respects legally held after due notice had been given, and the returns duly and legally made, and showing the following results:

MIDLOTHIAN ISD - PROPOSITION A

Shall the board of trustees of Midlothian Independent School District be authorized to issue and sell bonds of the District in the principal amount of \$356,004,800 for the purpose of acquiring, constructing, renovating, improving and equipping school buildings of the District, for the purchase of necessary sites for school buildings; and shall there be levied, assessed and collected annually ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds as the same become due and to pay the costs of any credit agreements executed or authorized in anticipation of, in relation to or in connection with the bonds; said bonds to be issued in one or more series or issues, to mature serially or otherwise not more than 40 years from their date, and to bear interest at such rate or rates not to exceed the limit prescribed by law at the time of issuance, as the board of trustees in its discretion shall determine?	<u>2,562</u>	VOTES FOR

Shall the board of trustees of Midlothian Independent School District be authorized to issue and sell bonds of the District in the principal amount of \$48,664,600 for the purpose of, acquiring, constructing and equipping storm shelters at Baxter Elementary School, Miller Elementary School, McClatchey Elementary School, Frank Seale Middle School and Walnut Grove Elementary School, including the acquisition of land therefor; and shall there be levied, assessed and collected annually ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on said bonds as the same become due and to pay the costs of any credit agreements executed or authorized in anticipation of, in relation to or in connection with the bonds; said bonds to be issued in one or more series or issues, to mature serially or otherwise not more than 40 years from their date, and to bear interest at such rate or rates not to exceed the limit prescribed by law at the time of issuance, as the board of trustees in its discretion shall determine?	<u>2,241</u>	VOTES FOR
